

**South Utah Valley Electric Service District
Public Hearing – Rate Schedules
September 28, 2022**

South Utah Valley Electric Service District (SESD) held a public hearing at 6:00 p.m. on Wednesday – September 28, 2022 at the SESD office located in Payson, Utah.

At 6:00 p.m. Ray Loveless welcomed everyone, called the meeting to order, and offered a prayer.

PUBLIC FORUM

No public in attendance.

MOTION TO APPROVE RATE SCHEDULE 11

Mark Holdaway explained that Rate Schedule 11 is the new rate schedule created for large load connections *less than* 1000KW.

MOTION TO APPROVE RATE SCHEDULE 12

Mark Holdaway explained that Rate Schedule 12 is the new rate schedule created for large load connections *greater than* 1000KW.

Ray Loveless clarified that Rate Schedule 11 and Rate Schedule 12 are exclusive of one another. Ray stated that the rates are not tiered; customers will be charged one rate or the other, not both. Ryan Bagley reviewed additional details of each rate component including the customer charge, power rate (demand charge), energy rate (kWh), and facilities charge. Nelson Abbott thanked Ryan Bagley for the clarification and stated that he does not want the customers that he represents, regular residential customers, to subsidize large load connections.

Brent Winder made a motion seconded by Kenny Seng to approve Rate Schedule 11 as presented. Nelson Abbott, Brent Gordon, Ray Loveless, Kenny Seng, and Brent Winder approved the motion.

Brent Gordon made a motion seconded by Brent Winder to approve Rate Schedule 12 as presented. Nelson Abbott, Brent Gordon, Ray Loveless, Kenny Seng, and Brent Winder approved the motion.

MOTION TO APPROVE CHANGES TO TARIFF TABLE OF CONTENTS

Mark Holdaway presented the revised *Tariff Table of Contents* including edits due to new content in Rate 10 and the addition of Rate Schedules 11 and 12.

Nelson Abbott made a motion seconded by Kenny Seng to approve the revised Tariff Table of Contents 11 as presented. Nelson Abbott, Brent Gordon, Ray Loveless, Kenny Seng, and Brent Winder approved the motion.

MOTION TO APPROVE LANGUAGE CHANGES IN RATE SCHEDULE 6

Mark Holdaway stated that the language changes in Rate Schedule 6 were included to protect large loads of non-residential agricultural food processing customers, of which SESD has only one, McMullin Orchard’s BIG M Frozen Storage.

Ray Loveless inquired about BIG M’s peak load.

Mark Holdaway stated that the peak load of BIG M Frozen Storage is approximately 900KW.

Nelson Abbott made a motion seconded by Kenny Seng to approve the revised language in Rate Schedule 6. Nelson Abbott, Brent Gordon, Ray Loveless, Kenny Seng, and Brent Winder approved the motion.
